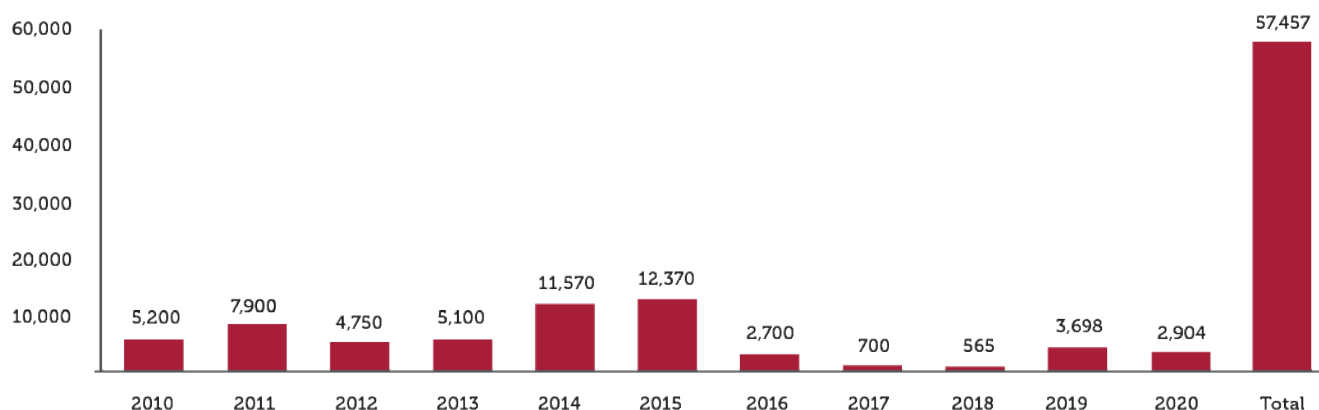

The Genghis Capital Unit Trust Fund is a Collective Investment Scheme (CIS) which was approved by the Kenyan regulator, the Capital Market Authority (CMA), in December 2011. The scheme currently houses the Genghis money market fund: Gencap Hela Imara.

Who is involved in a unit trust?



This fund is designed for conservative investors who have a low tolerance for risk.

Interest is calculated daily and deposited into the client's account on a monthly basis, allowing for easy access.

The minimum investment and top-up amount is Kshs. 500, and the interest rate is published daily. The rate is gross, excluding withholding tax on interest earned.

Investing in this fund has become more appealing and convenient due to the increasing assets under management (AUM) and the availability of the G-Kuze app.

5 Reasons why you should open a Hela Imara Account

1. Capital Preservation - Investments are made in short term secure investments.

2. Liquidity - You can cash in all or part of your investments at any working day, as and when the need arises, and the process will take 2 - 4 working days without losing out on already earned interest.
